

# **YES PLEDGE REQUEST**

We have come to a critical time in the referendum for constitutional recognition through a Voice for Aboriginal and Torres Strait Islander peoples.

There is solid majority support, but we are in a contested space. It is important to reinforce the majority support for a winning campaign.

We know that listening to the voices of Indigenous Australians on the issues that affect their families and communities is critical to getting better outcomes. The referendum itself is a call from Aboriginal and Torres Strait Islander people, through the Uluru Statement from the Heart, to take a significant step forward for reconciliation.

What Yes23 needs now is to swell our ranks of supporters, so we can build the volunteer power needed to drive the campaign forward. It will also be a strong demonstration of public support.

We ask that you email your supporters, as well as using your other communications channels, calling for them to sign our pledge to vote 'Yes' in the referendum. You can also use social media and your other communications channels to call for people to sign the Yes pledge.

Below we have provided some topline points on effective messages for getting support for the Voice from a broad audience. We have also drafted a model email. However, it's important to put that email in your organisation's own voice and words.

# **KEY MESSAGING POINTS**
